APPROVAL OF MINUTES:

Bruce made a motion to approve the February 2016 Board Meeting Minutes. Ron seconded. All in favor.

FINANCIALS:

1612 Palm Tree Removal, incident

Mack Tree Service was contacted to remove Dead Palm tree on the Bryant's deck # 1612. The request was in response of neighbor in concern that the dead palm may fall onto the homes or decks. Inadvertently, another palm on Bryant's deck was also removed, the Bryant's were very upset over this and also had deck boards damaged during this process. Board members have visited the Bryant's and looked at the deck damages.

There was discussion on how to repair the deck and resolve the issue. Mack Tree Service is a subcontractor and responsible for damages, he is aware of this fact.

Cheryl will contact Mack Tree service, to coordinate the Palm replacement and Deck Repairs as agreed to by Bryant's and Tree Service.

In summary it was decided by Board, Palm Trees will be trimmed by Association, Owners should notify management if they do not want deck palms trimmed.

C. Sound Side Drainage update

Cheryl, Mike and Charlie Miller had a meeting at County offices with Commissioner, Grover Robinson and engineers on September 3, 2015, regarding Santa Rosa Villa Townhomes, Bulevar Menor road flooding, sound side, during heavy rains. After discussion and presentation of pictures verifying the flooded road, it was decided that County would help to alleviate the flooding by cutting areas and lying of pervious cement, until a more permanent solution could be funded. To date, this has not taken place. Cheryl continues to follow up with county for a timeline for the repairs. **Tabled, still awaiting County to respond as promised**.

D. Updating of Rules and Regulations:

Board agreed until revitalization of Documents is completed, Rules and Regulations will stay as is. EPM office will re-type and send the current rules to owners by email and mail.
