**ARTICLE VII
MEMBERSHIP IN THE ASSOCIATION; VOTING RIGHTS**

Section 7.02 On all matters upon which the membership shall be entitled to vote, each member shall be entitled to ~~one vote for each Unit owned in Sailmaker's Place Condominium~~ vote the number of votes as set forth in Exhibit B to the Declaration of Condominium which vote may be exercised or cast by the owner of each Unit in the manner provided in the Bylaws (Exhibit D) adopted by the Association and as amended, from time to time, and in accordance with applicable provisions of the Florida Statutes.

**ARTICLE XIII
RESIDENTIAL USE RESTRICTIONS APPLICABLE TO CONDOMINIUM UNITS**

Section 13.01




